CPD's Property Crimes Arrests for September 2025

The Columbus Police Department's Property Crimes Unit continues to aggressively investigate and address crimes that directly impact our community's quality of life. In September 2025 alone, investigators arrested 28 individuals on a combined 220 charges. These cases represent a wide range of property-related crimes, including entering autos, motor vehicle thefts, burglaries, thefts involving firearms, shoplifting, financial fraud, and more.
