WHEREAS the Governors of Georgia and Alabama have designated the Columbus Department of Planning as the Metropolitan Planning Organization (MPO) for the Columbus-Phenix City (C-PCTS) urban area; and

WHEREAS it is necessary to amend the Alabama section of the 2045 Metropolitan Transportation Plan and the 2024-2027 Transportation Improvement Program (TIP) to delete the ROW phase of project #100077209 at the request of per Alabama Department of Transportation; and

- RW Intersection Improvements at SR-1 (US-431) and SR-165 including additional northbound right turn lane, southbound left turn lane, and northbound acceleration lane along SR-1 (US-431) and additional left turn lane along SR-165 to Seale Rd. Target Start Date 12/1/2024, Est Eng Cost \$51,005.

BE IT RESOLVED that the Columbus-Phenix Transportation Study Policy Committee approve the amendment of the 2024-2027 TIP and the Metropolitan Transportation Plan (MTP).
