- Amendment to the 2024-2027 TIP to add project #100078390 in Phenix City, AL to Resurface Fontaine Road from 6th Place South to Brickyard Road. This project is funded by the Rebuild Alabama Grant Program and the costs will be \$350,000 for CN and will come through the State.
